- NOTE: Sending inadequate invoice documentation or incomplete/incorrect forms will delay incentive payment. Please make a copy of all documents for your records.
- Complete an application form for each installation address.

- Be sure to include vendor quotes and equipment specification sheets with the completed application.

- The maximum total incentive payment per member for all eligible projects and equipment types purchased and installed between January 1, 2012 and December 31, 2012 is \$25,000 per year.

GENERAL ELIGIBILITY

- Incentives are available for retrofit of functioning equipment, replacement of failed or non-functioning equipment, or addition of new equipment where none existed in an existing facility.
- Incentive items must be installed on the electric cooperative account listed on the application.
- All equipment must be new; used or rebuilt equipment is not eligible for an incentive.
- Equipment must meet the Technical Specifications listed in this application form. The Power Moves Program reserves the right to withhold payment for products that do not meet the requirements.

APPLICATION DELIVERY

- A signed application and installation invoice(s) must be received by Power Moves Program within 60 calendar days of the installation completion date. Invoice(s) submitted must include manufacturers' make and model numbers for each incentive item and/or original equipment manufacturer (OEM) specification sheets. Call your local cooperative for additional information.
- All completed submissions become the property of Wabash Valley Power Association and will not be returned. Please keep a copy for your records.

PAYMENT

- The incentive payment cannot exceed 75% of total project cost. Self labor cannot be included in total project cost.
- The Power Moves Program will issue incentives in the form of checks to the member. Incentives will not be issued as utility bill credits.

VERIFICATION

- Wabash Valley Power Association reserves the right to inspect a member's facility for installation of materials listed on this incentive application and will need access to survey the installed project. If the inspection finds the member did not comply with program rules and standards, any incentive you have received must be returned to Wabash Valley Power Association.
